ARTICLE I - Name

The name of this corporation is SEAT YOURSELF FURNITURE, INC.

ARTICLE II - Purpose

This corporation is organized for the following purposes:

A. To design, assemble, upholster, repair, and refinish furniture; to manufacturer, sell, export, import, or otherwise deal in furniture, furnishings, fixtures, fittings, equipment, devices, and articles of all kinds and description for use in or on public or private buildings or structures, whether made of metal, wood, plastics or other material or a combination of materials.

B. For the purpose of transacting any and all lawful business.
