

ARTICLES OF INCORPORATION

OF

NEURO MUSCULAR MASSAGE THERAPIES, INC.

ARTICLE I - NAME

The name of this corporation is NEURO MUSCULAR MASSAGE THERAPIES, INC.

ARTICLE II - DURATION

2-12.99

ALCO THE SALES

This duration of the corporation is perpetual and the date of the commencement of the corporate existence is the date of subscription and acknowledgment of these Articles of Incorporation, i.e., conditioned upon said Articles of Incorporation being filed by the Department of State within five (5) days, exclusive of legal holidays, after such date: otherwise, the commencement of the corporate existence shall be at the time of the filing of the Articles of Incorporation by the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

The corporation is authorized to issue 100 shares of one dollar (\$1.00) par value common stock.

ARTICLE V - PREEMPTIVE RIGHTS

Every stockholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
