The undersigned subscribes to these Articles of ω ω Incorporation, natural persons competent to contract, herebyn form a corporation under the laws of the State of Floriga:

ARTICLE I: NAME

The name of this corporation shall be:

FSP CONSULTANTS, INC.

ARTICLE II: NATURE OF BUSINESS

The general nature of the business of the corporation and the objects and purposes proposed to be transacted and promoted or carried on by it are as follows:

- a) To engage in the fiber optic engineering field with emphasis on saftey and construction and any other activities legal in the State of Florida, the United States, or any other state, county, territory or nation.
- b) To buy, sell, lease, own, improve, mortgage, or otherwise acquire, hold and dispose of land and property, real, personal, and mixed for the purpose of engaging in any activity or business permitted by law.
