THE UNDERSIGNED subscribers to these Articles of Incorporation, being natural persons competent to contract, enter into these Articles for the formation of a corporation under the Laws of the State of Florida.

ARTICLE I - CORPORATE NAME:

The name of this Corporation is: **Royal Gardens Landscaping, Inc.**
5590 West 1st Court, Hialeah, Florida 33012

ARTICLE II - DURATION:

The Corporation shall have a perpetual existence.

ARTICLE III - NATURE OF BUSINESS:

The Corporation is to engage in any activities or businesses permitted under the Laws of United States and the Laws of Florida, and in general, either alone or in association with other corporations, firms, or individuals, to carry on any lawful pursuit, and shall have all the additional powers now and hereafter conferred upon it by Law.

ARTICLE IV - CAPITAL STOCK:

The maximum number of shares which this Corporation is authorized to have outstanding at any time is ONE HUNDRED (100) shares of Common Stock having a par value of ONE DOLLAR (\$1.00) per share. All or any part of the capital stock may be paid for either in lawful monies of the United States of America, or in other assets transferred to the corporation, at a true valuation as of the time of the exchange for stock. All Common Shares shall be identical in value with each other in every respect and the holders thereof shall be entitled to one vote for each share upon all matters on which shareholders have the right to vote.

ARTICLE V - PROPERTY OF STOCKHOLDERS:

The private property of the stockholders, officers and directors of the Corporation shall not be subject to the payment of the obligations of Corporation to any extent.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT:

The street address of the initial registered office of this Corporation shall be **5590 West 1st Court., Hialeah, Florida 33012**, and the initial registered agent for the Corporation at that address shall be **Reynaldo Escobar**, who upon accepting this designation agrees to comply with the provisions of section 48.091, Florida Statutes, as amended, with respect to keeping and office open for service of process. Other offices for the transaction of business may be located wherever the Directors may deem necessary or expedient.

ARTICLE VII - INITIAL BOARD OF DIRECTORS:

The initial Board of Directors shall consist of ONE (1) member. The number of directors may be increased or decreased at any time by vote of the stock holders. The names and addresses of the directors constituting the initial Board of Directors are:

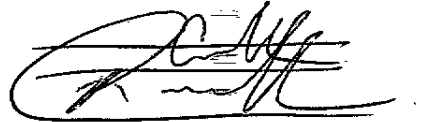
ARTICLE IX - INDEMNIFICATION:

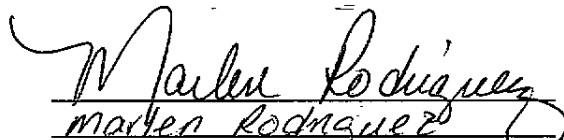
