The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation is S & G HOMES, INC.

ARTICLE II

Principal Office

The principal office and mailing address of the corporation shall be 8400 Roosevelt Boulevard, Jacksonville, Florida 32210.

Duration

This corporation shall exist perpetually.
