**ARTICLE OF INCORPORATION

**ARTICLE I: NAME**

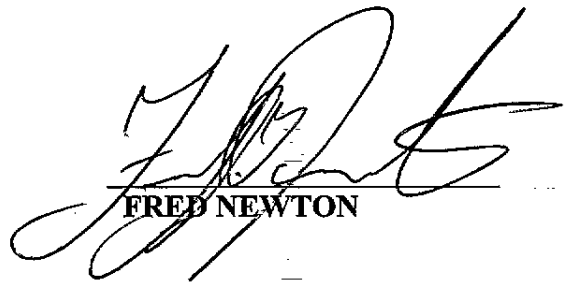
## **ARTICLE IX: INDEMNIFICATION**
