ARTICLES OF INCORPORATION

OF

RICH'S ELECTROBAKE GROUP, INC.

ARTICLE ONE

The name of the corporation is Rich's Electrobake Group, Inc. The principle office is located at 6725 Haines Road North, St. Petersburg, Florida 33702.

ARTICLE TWO

The period of duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.
