

The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby forms a corporation under the laws of the State of FLORIDA.

# ARTICLE I NAME

The name of this corporation is T&T LAWNCARE, INC.

#### <u>ARTICLE II</u> NATURE OF PROFESSIONAL BUSINESS
