The undersigned, acting as Incorporator, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act and the Professional Service Corporation and Limited Liability Company Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I
NAME
