Dear Ms. Harris:

Team Energy was previously based in Jacksonville. This past January...my wife left on vacation to Massachusetts with my 3 year old daughter and never came home. I ended up chasing them up to Massachusetts to try to convince them to come back to Florida. She told me she wanted a divorce and would not allow me to even communicate with my daughter until she received all the proceeds from the sale of our home in Orange Park Florida.

The State of Florida has been battling Massachusetts over the last (6) months on trying to secure myself visitation for my daughter. During this period...Team Energy has been on hold. I took on a couple of small consultant contracts (1099 agreements off my Social Security #) that would allow me to be up north for business. My intentions were to try to convince my wife of allowing me to visit with my daughter and also try to work out a mutual visitation plan that would allow my daughter to come down to Florida to visit with me throughout the year. I finally gave up this past month. I never changed my Florida license or vehicle registration. I knew I was going to stay in Florida. I just had to try to fight to be able to at least communicate with my daughter.

Because of the way my wife arranged for our mail to be transferred to Massachusetts (without my consent)...I and Team Energy have not received many correspondences, including the State of Florida's forms for filing Team Energy's annual corporation report. I re-established Team Energy here in St. Petersburg this past month and called my accountant to go over changes. At this time, is when I discovered that I have missed payment referencing Team Energy's annual corporation filing.

Ms. Harris...my personal life has been and still is as low as it gets. I have only been able to talk to my daughter over the last several months...with no visitation whatsoever. I am living off credit cards while I am in the re-building stage of my company. I am enclosing a check for \$150 representing Team Energy's annual corporation filing fee.
