# ARTICLES OF INCORPORATION

# EDUARDO LEISECA, E.A., P.A.

The undersigned subscriber to these Articles of Incorporation, natural person, competent to contract, hereby forms a corporation under the laws of the State of Florida.

# ARTICLE I - CORPORATE NAME

The name of the corporation is **EDUARDO LEISECA, E.A., P.A.** 

## ARTICLE II - DURATION

This corporation shall exist perpetually unless dissolved according to Florida law.

## ARTICLE III - PURPOSE

The nature of business of the corporation and the objects and purposes proposed to be transacted by said corporation are:

- 1. To engage in every aspect of the general service of taxation and accounting as an Enrolled Agent, including all fields of specialization.
- 2. To provide professional taxation and accounting services only through the corporation's officers, agents and employees who are enrolled to practice before the Internal Revenue Service in good standing or otherwise legally authorized to render such services in the State of Florida.
- 3. To engage in any activity or business permitted for professional service corporations under the laws of the United States and of the State of Florida.

## ARTICLE IV - CAPITAL STOCK

The corporation is authorized to issue Five hundred shares (500) of One Dollar(s) (\$1.00) par value Common Stock, which shall be designated "Common Shares".

The whole or any part of the capital stock of this corporation shall be payable in lawful money of the United States of America or property, tangible or intangible, or labor or services actually performed for the corporation at a value to be fixed by the directors. Shares may not be issued until the full amount of the consideration for such shares has been paid. Neither promissory notes nor future services shall constitute full or part payment for the issuance of shares of the corporation.

No shares may be issued to or voted by any person other than an individual who is duly licenses or otherwise legally authorized to render the specific professional services for which the corporation was incorporated. No shareholder shall enter into a voting trust agreement or any other type of agreement vesting another person with the authority to exercise the voting power of any or all of this stock. Upon the offer to sell for cash any new or existing stock of this corporation of the same kind, class or series as that which he already holds, every shareholder shall have the right to purchase his pro rata part of such stock (as nearly as may be done without issuance of the fractional shares) at the price at which such stock is offered to others.

#### ARTICLE V - INITIAL REGISTERED AGENT AND OFFICE
