Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida for Profit Corporation adopts the following articles of amendment to its articles of incorporation.

FIRST:

Article III of this corporation's Articles of Incorporation be amended to read in its entirety as follows:

The aggregate number of shares which the Corporation shall have the authority to issue shall be 100,000,000 shares of common stock at par value of .001 per share.

All of said stock shall be payable in cash, patents, stock, notes, accounts, claims, real estate or other property at a just valuation to be fixed by the Board of Directors at a meeting called for that purpose. Property, but not labor or services, may be purchased or paid for with the capital stock at a just valuation to be fixed by the Board of Directors at a meeting called for that purpose.
