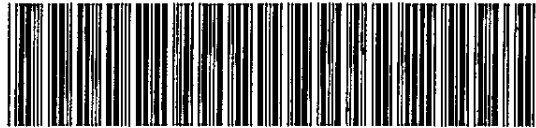



Pursuant to the provisions of Section 607.1101, Florida Statutes (2004), the undersigned corporations certify as follows:

1. The constituent corporations participating in this merger are GLOBAL SOURCING & TRADING, INC., a Florida corporation (hereinafter referred to as the "Surviving Corporation"), and HWK INVESTMENTS 1, INC., a Florida corporation (hereinafter referred to as the "Merging Corporation").

2. The name of the Surviving Corporation is GLOBAL SOURCING & TRADING, INC., and is to be governed under the laws of the State of Florida.

3. A Plan of Merger was approved by the Board of Directors and Shareholders of the constituent corporations on June 25, 2004, pursuant to Section 607.1103, Florida Statutes (2004).

4. The Articles of Incorporation of the Surviving Corporation, as now in force and effect, shall continue to be the Articles of Incorporation of the Surviving Corporation until amended or changed pursuant to the provisions of the Florida General Corporation Act.

5. Each share of the capital stock of the Merging Corporation shall be surrendered and cancelled and exchanged for the same number of shares of the authorized capital stock of the Surviving Corporation.

6. The effective date of the merger shall be the date upon the filing of these Articles of Merger with the Secretary of State.

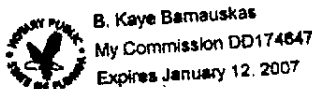

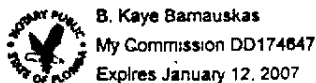
