The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be: Paradise Technologies, Inc.

The principal place of business of the corporation shall be, and the mailing address of the corporation is: 910 Grinnell Street, Key West, Florida 33040.

ARTICLE III

The capital stock of this corporation shall be 10,000 shares of common stock having a par value of \$1.00 per share.

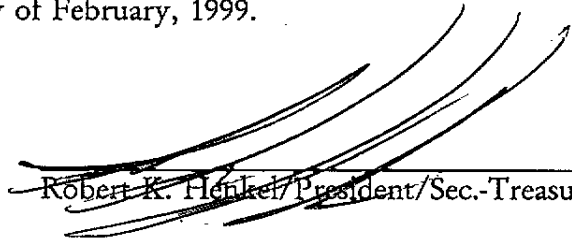
ARTICLE VII

The manner and form, as well as the relevant terms, conditions, and details of the disposition, shall be determined by the shareholders of the corporation; provided, however, that such regulatory or restrictive provisions shall not affect the rights of third parties without actual notice of the provisions unless the existence of the provisions is plainly noted on the certificate evidencing the ownership of such stock.

ARTICLE VIII

The corporation reserves the right to amend or repeal any provisions in these articles of incorporation in the manner provided by law. Any rights conferred on the shareholders are subject to this reservation.
