## ARTICLES OF INCORPORATION OF BLUE WATER GAMING, INC.

The undersigned Incorporator, John O. Anthony, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

#### ARTICLE I:

The name of the Corporation (hereinafter "Corporation") shall be: Blue Water Gaming, Inc.

#### **ARTICLE II:**

The purpose or purposes of the Corporation shall be to engage in any activity, business, or lawful act under the laws of the State of Florida and the United States.

#### ARTICLE III:

The principal place of business and mailing address of the Corporation shall be: Port of Miami, 1265 South America Way, 1st Floor, Miami, Florida 33132.

#### **ARTICLE IV:**

The number of shares of stock that the Corporation will be authorized to have outstanding at any one time shall be: ten thousand (10,000) shares of single class stock.

The remaining four thousand (4,000) shares of stock shall not be issued without the affirmative vote of one hundred percent (100%) of all issued and outstanding shares of the Corporation. This provision of the Articles of Incorporation may not be amended without the affirmative vote of one hundred percent (100%) of all issued and outstanding shares of the Corporation.

## ARTICLE VI:

FILLU LARY OF STATE HELDE UDREPRATIONS

The Corporation shall have four (4) Directors at inception. The number of Directors may be increased or decreased from time to time by the Bylaws.
