**ARTICLES OF INCORPORATION  
OF  
PARALLEL HOTELS, INC.**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of the corporation is: **PARALLEL HOTELS, INC.**

**ARTICLE II - TERM OF EXISTENCE**

This corporation is to exist perpetually, and is prohibited from any dissolution, liquidation, consolidation, merger or asset sale as long as the loan from LaSalle National Bank, as Trustee for registered holders of LB Commercial Conduit Mortgage Trust, Multiclass Pass-Through Certificates, Series 1995-C2, is outstanding.

**ARTICLE III - NATURE OF BUSINESS**

This corporation is formed for the sole purpose of purchasing, financing and operating the Quality Inn & Suites, 2020 Apalachee Parkway, Tallahassee, Leon County, Florida 32301. This corporation is prohibited from incurring any indebtedness other than the first mortgage held by Lasalle National Bank, as Trustee for registered holders of LB Commercial Conduit Mortgage Trust, Multiclass Pass-Through Certificates, Series 1995-C2, which secures the loan. The corporation cannot give guarantees of any debt or obligation of another. Unsecured trade debt arising from the daily operations and management of the property is permissible.

#### **ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue One Hundred (100) shares of common stock at one dollar (\$1.00) per share.

#### **ARTICLE V - PRINCIPAL OFFICE**
