

*Articles of Incorporation of  
Schroeder/Perez/Johnson, P.A.*

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract and legally authorized to practice in the profession of architecture in the State of Florida, hereby proceeds to form a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I--NAME

The name of this corporation is Schroeder/Perez/Johnson, P.A.

ARTICLE II--PURPOSE AND NATURE OF BUSINESS

The purpose of the Corporation and the nature of its business are as follows:

To render architectural services to the public, which shall include planning, designing, evaluating, investigating and superintending the construction of sites, buildings or architectural structures; preparing architectural drawings and specifications; evaluating bids upon architectural proposals; preparing architectural drawings and specifications; evaluating bids upon architectural proposals. This professional corporation shall exist and function in compliance with the "Florida Professional Service Corporation Act" (F.S.A. Chapter 621) and in order to properly prosecute the objects and purposes above set forth, the Corporation shall have full power and authority to purchase, lease and otherwise acquire, hold, mortgage, convey and otherwise dispose of all kinds of property, both real and personal, necessary for the rendering of architectural services.

ARTICLE III--CAPITAL STOCK

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is 1,000 shares having a par value of \$10.00 per share. Such shares shall be of a single class of common stock. None of the shares of the Corporation may be issued to any entity or individual who is not duly licensed in the State of Florida in the profession of architecture.

ARTICLE IV--DURATION

The Corporation shall have a perpetual existence.

## ARTICLE V--ADDRESS AND AGENT

The street address of the principal and initial registered office of the Corporation is 3898 North Tamiami Trail, Suite 202, Naples, Florida 34103, and the name of its initial registered agent is A. Michael Johnson. The Board of Directors may, from time to time, move the office to any other address in the State of Florida and change the registered agent.

## ARTICLE VI--DIRECTORS

No shareholder may sell or transfer his shares in the Corporation except to another individual who is eligible to be a shareholder of the Corporation under Florida law.


## ARTICLE IX--DISQUALIFICATION


