Articles of Incorporation

Express Laundry, Corp.

The undersigned person acting as incorporator for the purpose of forming a stock business corporation under the laws of the State of Florida, adopts the following Articles of Incorporation:

- Article 1.** The name of the corporation shall be Express Laundry, Corp.
- Article 2.** The initial principal office and mailing address of the corporation is 1108 North 13th Avenue, Hollywood, Florida, 33019.
- Article 3.** The corporation shall have the authority to issue one class of shares with unlimited voting rights and the authority to receive the net assets of the corporation upon dissolution. The corporation is authorized to issue one hundred (100) shares of stock.
- Article 4.** This corporation shall have preemptive rights for all shareholders.
