The Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by Law.

#### Article XIV - Action by Directors Without a Meeting

The Directors of the Corporation may take action by written consent, as provided by law, except the following actions must be taken at a meeting of Directors:

2. Sale of Corporate Assets.
