

- The name of the corporation is SAMUELS & ASSOCIATES DENTAL, P.A. (the "Corporation").

- The aggregate number of shares which the Corporation is authorized to issue is 10,000 shares of Common Stock, par value \$.01 per share.
- The street address of the initial registered office of this Corporation is 3050 Biscayne Boulevard, Suite 801, Miami, Florida 33137, and the name of the initial registered agent of this Corporation at that address is Craig M. Dorne.
