Article I Name**

The name of this corporation shall be Expert Tree Service of Bradenton, Inc.

Article II Commencement and Duration

The commencement of this corporation's existence shall be at the time of the filing of these Articles of Incorporation by the State of Florida. This corporation's duration is perpetual.

Article III Purpose

This corporation is being organized for the purpose of engaging in the transaction of any and all business activities permitted under the laws of Florida and the United States of America.

Article IIII Capitol Stock

This corporation shall have the authority to issue 1,000 shares of common stock at \$1 par value.

Article V Preemptive Rights

Every shareholder, upon the sale for cash, by this corporation of any shares of new capitol stock of the same kind, class or series, as that which the shareholder already holds, shall have the preemptive right to purchase pro rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which such shares are offered to others.

Article VI Transfer Restrictions

No Shareholder shall have the right to sell, assign, pledge, encumber, transfer, or otherwise dispose of any shares of the capitol stock of this corporation, with out first offering such shares for sale to this corporation at the net asset value thereof. Such offer shall be in writing, signed by the shareholder, sent by registered or certified mail to this corporation at it's registered office address, and open for acceptance by this corporation for a period of 15 days from the date of mailing. If this corporation fails or refuses, within such period, to make satisfactory arrangements for the purchase of such shares, the shareholder shall have the right to dispose of such shares without any further restrictions.

Articles of Incorporation for

Expert Tree Service of Bradenton, Inc.

On the death of any shareholder, this corporation shall have the right to purchase any shares of the capitol stock of this corporation owned by the shareholder immediately prior to the share holder's death, on the terms set forth above, and this provision shall be binding upon the personal representative of the shareholder.

Each stock certificate issued by this corporation shall carry the following legend:

**"These Shares Are Held Subject To Certain Transfer Restrictions

Article VII Initial Board of Directors

The number of directors on this corporation's Initial Board of Directors shall be 2. The number of directors may be increased or decreased from time to time, as provided in this corporations bylaws, but shall never be less than one.
