



The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

1. The name of the corporation is Computer BASE Corporation.
2. The period of its duration is perpetual.
3. The purpose of the corporation is to engage in any businesses or activities which are permitted under the laws of the United States and the State of Florida.
4. The corporation shall have authority to issue 10,000 shares of one dollar par value common stock.
5. The address of the corporation's initial registered office is 1140 N.E. Cleveland Street, Clearwater, FL 33755. The name of the registered agent at such address is Charles Perry.
6. The principal office of the corporation is 1140 N.E. Cleveland Street, Clearwater, FL 33755.
7. The number of directors constituting the initial Board of Directors is two, whose names and address are Lana Lease and Forest Ford.
8. The name and address of the incorporator is Charles Perry, 1100 Cleveland St., Clearwater, FL 33755.
9. The Board of Directors shall have authority to adopt a seal and stock certificates for the use of the corporation.
10. The corporation shall indemnify each director to the fullest extent permitted by law.


