CORPORATE NAME

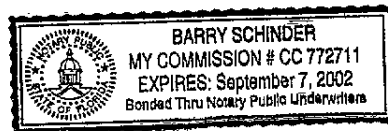


