# ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida hereby adopts the following Articles of Incorporation:
Article I,
<u>Name</u>
The name of the professional service corporation is JM Commercial Realty, Inc.
Article II
Nature of Business
This corporation is organized for the purpose of providing customers with assistance in the marketing and sale of real estate assets, and for the purpose of transacting any and all lawful business.
This corporation may also perform any service or activity that may be engage in by a registered real estate broker in the State of Florida, provided that neither the corporation nor its officers and employees, acting on behalf of the corporation, shall perform any such service or activity unless and until the corporation is registered and legally qualified to act as a real estate broker in the state in which such service or activity is to be performed.
Article III
Principal Office
The initial principal office and mailing address of the corporation is 1432 North 10 <sup>th</sup> Street, Jacksonville Beach, Florida 32250.
Article IV
Capital Stock
A. <u>Number: Par Value</u> . The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 10,000 shares of common stock having a par value of \$1.00 per share.
B. Preemptive Rights. Every shareholder, upon the sale for cash of any new stock of

this corporation of the same kind, class or series as that which he already holds, shall have the right to

purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

C. Restrictions on Transfer of Stock. Shares of capital stock of this corporation shall be issued initially to the following persons, in the amounts shown:

Other restrictions on the sale, transfer, or encumbrance of the stock, including the price and terms at which, and the time within which, such shares may be offered and sold, may be further specified by bylaw provision or by written agreement among all of the shareholders of this corporation.
