ARTICLES OF INCORPORATION

OF

POWER STORE, INC.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I.

The name of this corporation shall be: Power Store, Inc.

ARTICLE II.

The general nature of the business or businesses to be carried on or conducted by said corporation and its general objects and purposes, and among the general and special powers granted and reserved unto the corporation, shall be: to engage in every aspect of electronic and wireless retail sales.

To manufacture, purchase or otherwise acquire, and to own, mortgage, pledge, sell assign, transfer, or otherwise dispose of and to invest in, trade in, deal in and with, goods, wares, merchandise, real and personal property and services of every class, kind and description; except that it is not to conduct a banking, safe deposit, trust, insurance, surety, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, fraternal benefit society, state fair or exposition;

To conduct business in, have one or more offices in, and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks, and licenses in the State of Florida, and in all other states and countries;

To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages, transfers of corporate property, or

To purchase the corporate assets of any other corporation and engage in the same or other character of business;

To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities, or other evidences of indebtedness created by any other corporation of the State of Florida or any other state or government, and while owner of such stock to exercise all the rights, power and privileges of ownership, including the right to vote such stock; and

To exercise any of the powers enumerated in Florida Statutes §607.0302 as now or hereafter provided.

ARTICLE III.

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is:

1,000 shares at a par value of \$1.00 per share.

The restrictions contained in this Article or a reference thereto shall be noted on the reverse side of such shares of stock issued by the corporation.

The amount of capital with which this corporation will begin business is not less than Five Hundred and 00/100 (\$500.00).

ARTICLE VI.

The corporation is to exist perpetually.

ARTICLE VII.

This corporation shall have two (2) directors initially. The number of directors may be increased or diminished from time to time, as provided in the by-laws adopted by the stockholders, but shall never be less than two (2).

ARTICLE XI.

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders, and approved at a stockholders' meeting by a majority of the stock entitled to vote thereon, unless all the directors and all the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

ARTICLE XII.

The foregoing right of indemnification shall not be exclusive of any other rights to which any director or directors or officer or officers may be entitled as a matter of law.

ARTICLE XIII

No contract or other transaction between the corporation and any other firm or corporation shall be affected or invalidated by reason of the fact that any one or more of the directors or officers of this corporation is a member, stockholder, director or officer, or are members, stockholders, directors or officers of such other firm or corporation and any director or officer or officers, individually or jointly, may be a party to or parties to, or may be interested in, any contract or
