OF

The undersigned, acting as incorporator of a Florida corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME

The power to adopt, alter, amend, or repeal bylaws of the Corporation shall be vested in the shareholders of the Corporation.

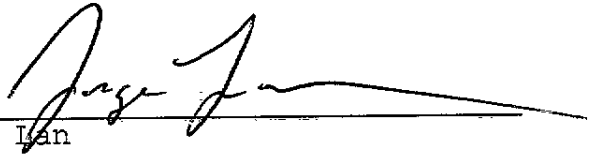
