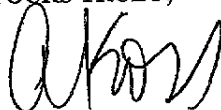

**FOURTH:** Adoption of Amendment:

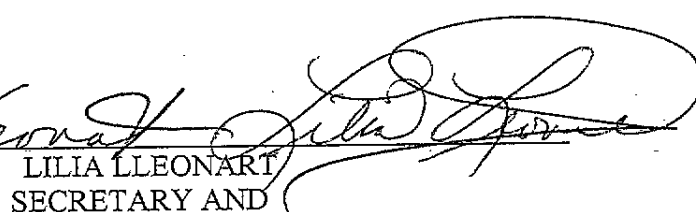
