CERTIFICATE OF INCORPORATION

OF

VARI EXPRESS CORP.

We the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida providing for the formation of a corporation for profit, with the powers, rights privileges and immunities hereinafter mentiones, and we hereby make, subscribe and acknowledge and file with the Secretary of State of Florida this Certificate, set forth:

ARTICLE I

The name of this corporation (which is hereinafter called the "Corporation" is: VARI EXPRESS CORP.

ARTICLE II
