**ARTICLES OF INCORPORATION**

**ARTICLE I. CORPORATE NAME.**

The name of this corporation is: **HAMMOCKS DOLLAR STORE INC.,**

**ARTICLE II. NATURE OF BUSINESS AND POWERS.**
