ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation shall be:

RUDD JONES, P.E. AND ASSOCIATES, P.A.

ARTICLE II - DURATION

The corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation, through its officers and employees, shall be authorized to engage in every aspect and phase of practicing accounting within the State of Florida; to engage in any activities which will facilitate and promote practicing engineering through its officers and employees; and to invest and reinvest its funds in real estate, mortgages, stocks, bonds and any other type of investments within the meaning of F.S. §621 of the Professional Service Corporation Act; and to purchase and own real and personal property necessary for the rendering of professional services within the practice of engineering.
