ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF CAV-AIR, INC.

2002 FEB - 5 AM II: 31 SECRE ARY OF STATE

Pursuant to Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of CAV-AIR, INC. (the "Corporation") are hereby amended according to these Articles of Amendment:

FIRST: The name of this Corporation is CAV-AIR, INC.

SECOND: Article I of the Articles of Incorporation is hereby deleted in its entirety and the following inserted in lieu thereof:
