ARTICLE VI**INITIAL REGISTERED OFFICE AND AGENT**

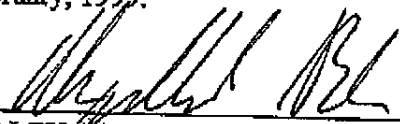
