

# GEORGE A. LANE, P.A.

The undersigned natural person licensed to practice law in the State of Florida, hereby declares his intent to form a professional service corporation in accordance with the Florida Professional Service Corporation Act, Chapter 621 of the Florida Statutes, and hereby adopts the following Articles of Incorporation for such corporation, *to become effective on March 1, 1999*.

#### **ARTICLE I**

# NAME AND PRINCIPAL MAILING ADDRESS OF CORPORATION

The name of the corporation is: **GEORGE A. LANE, P.A.** and its principal street and mailing address is One East Broward Blvd., Suite 1501, Fort Lauderdale, Florida 33301.

#### **ARTICLE II**

#### **PURPOSE OF CORPORATION**

This corporation is organized for the following purposes:

- A. To engage in the practice of law as a professional law corporation and to carry on services incident thereto. The practice of law is the sole and exclusive professional service to be rendered by this corporation.
- B. To own property, to enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.

C. The professional service of this corporation shall be carried out only through officers, employees, and agents, each of whom have been admitted to the bar of, and is duly authorized to practice law in, the State of Florida.

#### ARTICLE III

#### CAPITAL STOCK

This corporation is authorized to issue One Thousand (1,000) shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares."

# **ARTICLE IV**

# CAPITAL TO BEGIN BUSINESS

The amount of capital with which this corporation will begin to practice the profession of law shall not be less than ONE THOUSAND DOLLARS (\$1,000.00).

# **ARTICLE V**

#### **TERM OF EXISTENCE**

The corporation shall exist perpetually.

#### **ARTICLE VI**

# INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial Registered Office of this corporation is One East Broward, Suite 1501, Fort Lauderdale, Florida 33301. The name of the initial Registered Agent at that address is GEORGE A. LANE.

#### **ARTICLE VII**

# **INITIAL BOARD OF DIRECTORS**

The corporation shall have one (1) director initially. The number of directors may be either increased or diminished from time to time by the By-Laws, but shall never be decreased to less than one (1). The name and address of the initial director of the corporation is GEORGE A. LANE, One East Broward Blvd., Suite 1501, Fort Lauderdale, Florida 33301.

#### **ARTICLE VIII**

#### **INCORPORATOR**

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

# **ARTICLE IX**

#### INDEMNIFICATION

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.
