ARTICLES OF INCORPORATION
OF
GRAFOLD INDUSTRIES, CORP.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adapts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is GRAFOLD INDUSTRIES, CORP.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the State of Florida and the United States of America. This shall include, but not be limited to: manufacturing, assembling, international business trading, research business opportunities in the United States and overseas, assist in the importing/exporting of products worldwide, develop and maintain worldwide business relationships and all other related activities.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue One Thousand (1,000) shares of \$0.10 par value common stock.

This corporation is to exist perpetually.

ARTICLE X - AMENDMENT


