Pursuant to §607.1006, *Florida Statutes*, the undersigned, as President of CENTERNET, INC., a Florida corporation ("Corporation"), does hereby certify that the amendment provided for herein to change the number of authorized shares of capital stock of the Corporation was adopted by the written consent of the sole shareholder and sole director of the Corporation pursuant to §607.0704 and §607.0821, *Florida Statutes*, on the 20th day of September, 2000, and that the number of votes cast for the said amendment by the sole shareholder was sufficient for approval. The document number of the Corporation is P99000016784.

1. The name of the Corporation is CENTERNET, INC.
2. Article III (CAPITAL STOCK) of the Articles of Incorporation of the Corporation is amended to read in its entirety as follows:

The number of shares of stock that this corporation is authorized to have outstanding at any one time is Ten Million (10,000,000) shares of common stock having a par value of \$.0001 per share. The holders of common stock of this corporation shall be entitled to one (1) vote for each share held at all meetings of the stockholders of the corporation.

3. All other articles and provisions of the Articles of Incorporation as originally filed shall remain the same.
