**ARTICLE I – NAME**

The name of this corporation is EAGLE LAKE PHASE II DEVELOPMENT COMPANY located at 1688 W. Hibiscus Blvd., Melbourne, Florida 32901.

**ARTICLE II – DURATION**

This corporation shall have a perpetual existence commencing upon the date of subscription and knowledge hereof as provided by Florida Statute 607.0203.

**ARTICLE III – PURPOSE**

#### ARTICLE XIII – AMENDMENT




