

ARTICLES OF INCORPORATION Tavares Preschool & Learning Center, Inc.

ARTICLE I

ASTRONOMICS OF THE ROLL OF THE The name of this Corporation is TAVARES PRESCHOOL & LEARNING CENTER INC. and its address is 1201 E. Alfred Street, Tavares, Florida 32778.

ARTICLE II

This Corporation shall exist perpetually.

ARTICLE III

The Corporation is organized for the general purposes of transacting any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV
