ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is SJV Properties, Inc. and its principal place of business shall be located at 336 Redwing Lane, St. Augustine, Florida 32084.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of the Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

To do any and all other acts and things as are necessary or convenient to the attainment of the purpose of this corporation and any of them to the same extent as natural persons lawfully might or could do in any part of the world, insofar as such acts are permitted to be done by a corporation organized under the Corporate Law of this state.
