ARTICLES OF INCORPORATION
OF

ARTICLE I- NAME

The Name of this Corporation is HIGHGRADE ELECTRIC CONTRACTORS, CORP.

ARTICLE II- DURATION

This corporation shall have a perpetual existence commencing on the Date of Filing.

ARTICLE III- PURPOSE

This Corporation may engage in any activity of business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK


ARTICLE X- INCORPORATOR


