

ARTICLES OF INCORPORATION OF

This Corporation shall indemnify, defend, save and hold harmless and insure its officers and directors to the fullest extent permitted by law either now or as hereafter amended from time to time.


ARTICLE IX. PERPETUAL EXISTENCE
