#### ARTICLES OF INCORPORATION OF CLEAN COOL SYSTEMS, INC.

#### **ARTICLE I - NAME**

The name of this corporation is Clean Cool Systems, Inc.

#### ARTICLE II - ADDRESS

#### **ARTICLE III - CAPITAL STOCK**
