The undersigned incorporator hereby files these Art Frescof Incorporation in order to form a corporation under the laws of the State of Florida.

## ARTICLE I. Name of Corporation

The name of this Corporation shall be Advantage Printing & Graphics, Inc.

### ARTICLE II. Nature of Business
