The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

**ARTICLE I - NAME**

The name of this Corporation is INFORMATION WORLDWIDE CONSULTING, INC.

**ARTICLE II - NATURE OF BUSINESS**

The Corporation is a service corporation which will provide programming and consulting services to Businesses and the general public.

**ARTICLE III - CAPITAL STOCK**
