ARTICLE I - NAME AND PRINCIPAL OFFICE OF CORPORATION

Lema Industries, Inc. shall be the name of this corporation, and the mailing address and its principal office shall be: 6310 Memorial Highway, Tampa, Florida 33615.

ARTICLE II - NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III - CAPITAL STOCK


