ARTICLES OF INCORPORATION

OF

FLEET RESTORATION SERVICES, INC.

ARTICLE I

NAME

The name of this corporation is **FLEET RESTORATION SERVICES, INC.**

ARTICLE II

DURATION

This corporation shall exist perpetually.

ARTICLE III

PURPOSE

The general nature of the business to be transacted by this corporation is to manufacture, purchase, or otherwise acquire and to own, mortgage, pledge, sell, assign or otherwise dispose of, and to invest in, trade in, or deal in, any goods, wares, merchandise, or other real and personal property; and services of every class, kind and description. 
