ARTICLE I

CORPORATE NAME

The name of this corporation is S & L INTERNATIONAL TRADERS, INC.

ARTICLE II

PURPOSE

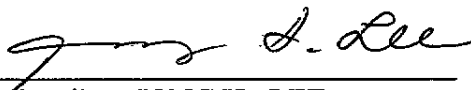
