The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation act, does hereby adopt the following Article of Incorporation:

**ARTICLE I**

**NAME**

The name of the Corporation shall be: **BARFIELD & ASSOCIATES OF OCALA, INC.**

**ARTICLE II**

**ADDRESS**

The address of the principle office of the Corporation is: 4904 SE 7<sup>th</sup> Place, Ocala, Florida 34471 and the mailing address of the Corporation is: P.O. Box 4338, Ocala, Florida 34478.

The Corporation shall have perpetual existence.

**ARTICLE IV**

**BUSINESS, OBJECTS OR PURPOSE**

The general nature of the business to be transacted by this Corporation or the objects or purposes of the Corporation shall be as follows:

1. To engage in and transact any lawful business for which corporation may be incorporated under the Florida Business Corporation Act and other incorporation laws of the State of Florida. No other purpose limits this general purpose in any way.
