ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation is JOHN'S MOBILE MECHANICS, INC.

ARTICLE II - DURATION

The corporation shall have perpetual existence commencing on the date of filing.

ARTICLE III - PURPOSE

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

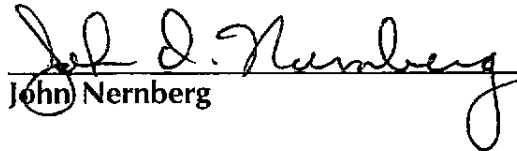
