Article I. Corporate Name and Initial Corporate Address

The name of this corporation is **The Old Bleau Corporation**, and the initial corporate street address is 14401 Front Beach Road, Panama City Beach, Florida 32413, and the initial corporate mailing address is Post Office Box 27536, Panama City, Florida 32411.

Article II. Nature of Business and Powers

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

Article III. Capital Stock

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 600 shares of common stock, having a par value of \$1.00 per share.
