The name of this corporation shall be: Trendline Investors INC.

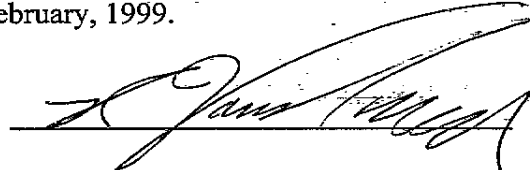

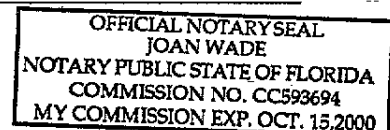
